Advanced Safeguarding Children (Level 2)



If your job role involves working frequently with children and/or their families, it's essential that you have an in-depth knowledge of safeguarding practices and procedures. This Advanced Safeguarding Children course builds upon your existing knowledge of safeguarding children and child protection through a variety of written text and interactive exercises.

The course will remind you about the different types of maltreatment, how to report your concerns and what happens after a referral is made to social care. It also provides you with information about the safeguarding framework, how to assess whether a child is at risk and the level of risk they are at, and the roles that different professionals play in safeguarding.

Aims of the training

At the end of this course, learners will be able to:

- Outline key legislation and the statutory framework which underpins safeguarding practice.
- Recognise the learnings from Child Safeguarding Practice Reviews.
- Identify different types of maltreatment and indicators of potential concerns.
- Identify additional vulnerabilities and risk factors for children.
- Recognise the impact trauma and abuse have on children.
- Recognise the roles of different agencies and identify when and how to work with them.
- Recognise the importance of understanding their local threshold document and how to respond appropriately to children's differing levels of need within the safeguarding framework.
- Outline best practice for making a safeguarding referral.
