# Ladder Safety



This Ladder Safety course is designed for anyone who regularly uses ladders or stepladders. It provides an introductory, yet comprehensive, overview of how to safely and competently use ladders and stepladders in various environments.

With proper training, ladder users will be able to confidently select, carry out pre-use checks, set up and use ladders correctly. Along with the risk assessment, this understanding will reduce the likelihood of accidents happening in the workplace.

#### **Module One: Introduction to Ladder Safety**

This module explains the consequences of and common hazards associated with poor ladder use, who is at risk, and what the employer and employees are responsible for.

#### **Module Two: Legal Responsibilities**

This module explains the specific regulations that apply to working with ladders, including the detailed ladder requirements set out in the Work at Height Regulations. It also looks at what workplaces should do if accidents occur.

#### **Module Three: Risk Assessment**

This module discusses the steps required to carry out a risk assessment of ladders, what techniques to use and what hazards to look out for.

- What is a risk assessment?
- Who should carry out a risk assessment?
- Step 1: identify the hazards
- Step 2: determine who may be harmed and how
- Step 3: decide on precautions
- Step 4: record findings and implement controls
- Step 5: review and update

#### **Module Four: Inspection, Maintenance, and Storage**

This module looks at how to carry out pre-use and detailed visual inspections. It explains who is responsible for carrying out maintenance and repairs and how to properly store ladders.

#### **Module Five: Setting Up Ladders**

This module explains how to safely select, set up and secure ladders and stepladders. This includes the EN 131 standard that all new ladders must meet.

#### **Module Six: Using Ladders Safely**

- Detailed visual inspections, maintenance and repair procedures, and the safe storage conditions for ladders.
- The various safety practices you must follow when using ladders and stepladders, including setting them up, stabilising, transporting, and working on them.
